Notification of the Central Committee on the Price of Goods and Services

No. 106, B.E. 2562 (2019)

Regarding Additional Control of Transport of Old Coconut Fruit, White Coconut and Copra Imported from Foreign Countries

Whereas the Central Committee on the Price of Goods and Services already issued the Notification of the Central Committee on the Price of Goods and Services No. 64, B.E. 2562 (2019) regarding Control of Transport of Old Coconut Fruit, White Coconut and Copra Imported from Foreign Countries dated 4 July B.E. 2562 (2019), prescribing that there are 10 districts in 7 provinces which have been the controlled areas for the transport of the coconut as imported from foreign countries.

Whereas the Central Committee on the Price of Goods and Services passed the resolution on 22 August B.E. 2562 (2019), prescribing that the areas of Mueang District, Sai Buri District, Yaring District, Panare District, Nong Chik District and Mai Kaen District, Pattani Province shall be the additional controlled areas for the transport of old coconut fruit, white coconut and copra as imported from foreign countries in order to prevent smuggling the importation, to carefully supervise the transport of the coconut as imported from foreign countries, and not to affect the trade in the domestic products of coconut farmers.

By virtue of Section 9 (2) and Section 25 (4), (7) of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services therefore issues this Notification, as follows.

Article 1. This Notification shall come into force in all areas of the Kingdom for the period of one year as from the day following the date of its publication¹, except for there being the issuance of a new notification.

Article 2. The provision in Article 2 of the Notification of the Central Committee on the Price of Goods and Services No. 64, B.E. 2562 (2019) regarding Control of Transport of

Old Coconut Fruit, White Coconut and Copra Imported from Foreign Countries dated 4 July B.E. 2562 (2019) shall be repealed, and the following provision shall be used instead:

"Article 2. A person is prohibited from transporting the old coconut fruit as imported from foreign countries, whereby the quantity of which per each time of transport starts from seven thousand kilograms upwards, the white coconut as imported from foreign countries, whereby the quantity of which per each time of transport starts from two thousand and five hundred kilograms upwards, the copra as imported from foreign countries, whereby the quantity of which per each time of transport starts from one thousand and five hundred kilograms upwards, whether by land or by sea entering or leaving the following district areas. The aforesaid prohibition shall not be applicable to the person who receives a letter of permission from the Secretary-General of the Central Committee on the Price of Goods and Services or from the Official who is entrusted by the Secretary-General of the Central Committee on the Price of Goods and Services or from the Chairperson of the Provincial Committee on the Price of Goods and Services or from the official who is entrusted by the Chairperson of the Provincial Committee on the Price of Goods and Services or from the Provincial Commercial Officer for the province in the case where the transport entering or leaving such a province shall take place.

- (1) Khlongtoei District, Bangkok Metropolis,
- (2) Banglamung District and Sriracha District, Chonburi Province,
- (3) Sadao District and Na Thawi District, Songkhla Province,
- (4) Mueang District and Khuan Don District, Satun Province,
- (5) Mueang District, Surat Thani Province,
- (6) Su-ngai Kolok District, Narathiwat Province,
- (7) Mueang District, Chumphon Province,
- (8) Mueang District, Sai Buri District, Yaring District, Panare District, Nong Chik District and Mai Kaen District, Pattani Province."

Article 3. In the case where any person has received the letter of permission for the transport of the old coconut fruit, the white coconut and the copra as imported from foreign countries entering or leaving the areas stipulated under Notification of the Central Committee on the Price of Goods and Services No. 64, B.E. 2562 (2019) regarding Control of Transport of Old Coconut Fruit, White Coconut and Copra Imported from Foreign Countries

dated 4 July B.E. 2562 (2019) and the duration which is specified in the letter of permission for the transport does not expire on the date when this Notification comes into force, it shall be deemed that such a person is granted the letter of permission for the transport under this Notification, and the letter of permission shall be valid until the duration which is specified in the letter of permission for the transport expires.
