Notification of the Central Committee on the Price of Goods and Services

No. 14, B.E. 2563 (2020)

Regarding Declaration of Quantity and Place of Storage for Fresh Hen Eggs

Whereas the Central Committee on the Price of Goods and Services already issued the Notification of the Central Committee on the Price of Goods and Services No. 53, B.E. 2562 (2019) regarding Determination of Goods and Services under Control dated 3 July B.E. 2562 (2019), prescribing that the eggs are the controlled goods.

Whereas the Central Committee on the Price of Goods and Services passed the resolution on 27 March B.E. 2563 (2020), prescribing that the business operator who possesses the fresh hen eggs is required to declare information on the quantity and the place of storage in accordance with the rules, duration and methods of declaration as stipulated by the Secretary-General of the Central Committee on the Price of Goods and Services in order that the quantity of the fresh hen eggs under the management and monitoring shall be sufficient for the needs of the public.

By virtue of Section 9 (2) and Section 25 (4), (5) of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services therefore issues this Notification, as follows.

Article 1. This Notification shall come into force in all areas of the Kingdom for the period of one year as from the day following the date of its publication, except for there being the issuance of a new notification.

Article 2. The business operator who possesses the fresh hen eggs is required to declare information on the quantity and the place of storage. The rules, duration and methods of the declaration shall be in accordance with the stipulations made by the Secretary-General of the Central Committee on the Price of Goods and Services.
