Regulation of the Office of the Central Committee on the Price of Goods and Services

Governing Guidelines Relative to Declaration of Quantity, Place of Storage and Arrangement

of Account for Controlling Para Rubber,

B.E. 2562 (2019)

Whereas the Central Committee on the Price of Goods and Services has issued the Notification of the Central Committee on the Price of Goods and Services, No. 13, B.E. 2562 (2019) Regarding Declaration of Quantity, Place of Storage and Arrangement of Account for Controlling Para Rubber dated 22 January B.E. 2562 (2019) stipulating that the business operator of rubber who has the quantity of purchase per month starting five thousand kilograms upward is required to declare the name, the type, the available quantity, the quantity of purchase, the quantity of distribution, the quantity of use, the remaining quantity, the place of storage at the end of every month within the 10th date of the following month; the declaration of information starts from the information of February B.E. 2561 (2019) onwards.

In order that the procedure of receiving information by competent officials shall be in the same way, and the method of declaring such information by the business operator of rubber shall be clear, by virtue of Section 16 (5) of the Price of Goods and Services Act, B.E. 2542 (1999), the Secretary-General of the Central Committee on the Price of Goods and Services has therefore issued this Regulation, as follows.

Article 1. This Regulation is called the "Regulation of the Office of the Central Committee on the Price of Goods and Services Governing Guidelines Relative to Declaration of Quantity, Place of Storage and Arrangement of Account for Controlling Para Rubber, B.E. 2562 (2019)".

Article 2. This Regulation shall come into force as from the day following the date of its publication in the Government Gazette onwards.¹

Article 3. The business operator of rubber under the Notification of the Central Committee on the Price of Goods and Services, No. 13, B.E. 2562 (2019) Regarding Declaration of Quantity, Place of Storage and Arrangement of Account for Controlling Para Rubber dated 22 January B.E. 2562 (2019) shall proceed with the declaration of information in accordance with the guidelines relative to declaration of quantity, place of storage and arrangement of account for controlling para rubber as attached to this Regulation.

Article 4. The Secretary-General of the Central Committee on the Price of Goods and Services shall have charge and control of the execution of this Regulation.
