Notification of the Office of the Central Committee on the Price of Goods and Services, No. 28, B.E. 2563 (2020)

Regarding Additional Rules and Procedures in relation to Application, Permission,
Form of Letter of Permission and Method of Transport of Rice in State's Stock in which
the Committee on Rice Policy and Management Has Approved to Release to Industry¹

Whereas the Office of the Central Committee on the Price of Goods and Services issued the Notification of the Office of the Central Committee on the Price of Goods and Services, No. 17, B.E. 2563 (2020) Regarding Rules and Procedures in relation to Application, Permission, Form of Letter of Permission and Method of Transport of Rice in State's Stock in which the Committee on Rice Policy and Management Has Approved to Release to Industry dated 2 July B.E. 2563 (2020) stipulating the rules and procedures in relation to the application, the permission, the form of letter of permission and the method of the transport of the rice in the state's stock in which the Committee on Rice Policy and Management has approved to release to the industry, by stipulating that in applying for the permission, the copy of document showing that the applicant is the person who is eligible under the bid for the rice in the state's stock, issued by the Department of Foreign Trade, the Ministry of Commerce, shall be submitted together with the application.

Whereas the National Committee on Rice Policy and Management passed the resolution to entrust the Public Warehouse Organization and the Marketing Organization for Farmers to perform additional duties in the bid for the rice in the state's stock. Therefore, in order that the application for permission to transport the rice in the state's stock shall be convenient and consistent with the present situation and the aforesaid resolution of the National Committee on Rice Policy and Management; by virtue of paragraph two of Article 4 of the Notification of the Central Committee on the Price of Goods and Services, No. 23, B.E. 2563 (2020) Regarding Control of Transport and Arrangement of Account for Controlling Rice in State's Stock in which the Committee on Rice Policy and Management Has Approved to Release to Industry dated 1 July B.E. 2563 (2020), the Secretary-General of the Central Committee on the Price of Goods and Services therefore issues this Notification, as follows.

Article 1. This Notification shall come into force as from the date of its publication.

Article 2. The provision in Article 5 (3) of the Notification of the Office of the Central Committee on the Price of Goods and Services, No. 17, B.E. 2563 (2020) Regarding Rules and Procedures in relation to Application, Permission, Form of Letter of Permission and Method of Transport of Rice in State's Stock in which the Committee on Rice Policy and Management Has Approved to Release to Industry dated 2 July B.E. 2563 (2020) shall be repealed, and the following provision shall be used instead:

"(3) the copy of document showing that the applicant is the person who is eligible under the bid for the rice in the state's stock, issued by the Department of Foreign Trade, the Public Warehouse Organization or the Marketing Organization for Farmers, as the case may be."
