Remarks :

1. In the case of the first time of declaration, it is not required to fill the information in a column "old".
2. In the case of distributing in a different manner from particulars or prices as having already been declared, it is required to fill the information in both a column "old" and the column "new".
 - 2.1 Particulars as having been declared are the declaration of new goods or the declaration of old goods which the details are changed.
 - 2.2 Prices as having already been declared are the declaration of the prices of goods whereby there are changes to the old prices as having already been declared.
3. In declaring the information of goods in each particular, it is required to fill out only the particular that is specified by the Notification
4. In the case where there is not enough space to fill out information, additional documents can be attached.
5. As for a column "price of distribution", a producer, an importer of goods into the kingdom for distribution shall declare the price at a factory and a wholesale price except for the case of directly distributing goods to a consumer, the declaration of a retail price being required. In the case of a sole distributor, it is required to declare both wholesale and retail price
6. In the case of declaring a discount, it is required to clearly specify the discount or a condition for giving the discount to each purchaser.
