## Notification of the Central Committee on the Price of Goods and Services

No. 5, B.E. 2565 (2022)

Regarding Determination of Additional Goods under Control

Whereas the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, already issued the Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2564 (2021) regarding Determination of Additional Goods under Control dated 27<sup>th</sup> January B.E. 2564 (2021) to prescribe 4 items of controlled goods, and the Notification of the Central Committee on the Price of Goods and Services No. 8, B.E. 2564 (2021) regarding Determination of Goods and Services under Control dated 28<sup>th</sup> June B.E. 2564 (2021) to prescribe 46 items of controlled goods and 5 items of controlled services.

Whereas the Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2564 (2021) regarding Determination of Additional Goods under Control dated 27<sup>th</sup> January B.E. 2564 (2021) has enforcement only for one year. And the Central Committee on the Price of Goods and Services has already reconsidered the exercise of such a power, it is of the view that there should be the maintenance of the four items of controlled goods; meanwhile, it is of the view that under the current circumstance and economic situation it is necessary to prescribe that chicken, chicken meat shall be additional goods under control, in order to monitor and prevent the fixing of purchase price, distribution price or the imposition of conditions and trade practices in an unfair manner.

By virtue of Section 9 (1) and Section 24 of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, therefore issues this Notification, as follows.

**Article 1.** This Notification shall come into force for the period of one year as from the date of its publication in the Government Gazette onwards <sup>1</sup>, except for there being the issuance of a new notification.

Article 2. The Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2564 (2021) regarding Determination of Additional Goods under Control dated 27<sup>th</sup> January B.E. 2564 (2021) shall be repealed.

Article 3. The following shall be goods under control:

- (1) hygienic mask,
- (2) polypropylene (spunbond) to be used in the production of hygienic mask,
- (3) product which contains alcohol as a component for hand hygiene,
- (4) waste paper and reused paper,
- (5) chicken, chicken meat.
