Notification of the Central Committee on the Price of Goods and Services

No. 22, B.E. 2564 (2021)

Regarding Prescription of Rules and Conditions Associated with Palm Oil in Storage Tank¹

Whereas the Notification of the Central Committee on the Price of Goods and Services No. 18, B.E. 2563 (2020) regarding Determination of Goods and Services under Control dated 1st July B.E. 2563 (2020) comes to an end, resulting in the end of enforcement of the Notification of the Central Committee on the Price of Goods and Services No. 32, B.E. 2563 (2020) regarding Prescription of Rules and Conditions Associated with Palm Oil in Storage Tank dated 1st July B.E. 2563 (2020). In the meantime, the Central Committee on the Price of Goods and Services has already reconsidered the exercise of its power regarding the stipulation of the aforesaid measure, it is of the view that there shall be the maintenance of the measure requiring the possessor of the storage tank of palm oil to proceed or cooperate with the Department of Internal Trade in installing the gauge for measuring the volume of palm oil contained in a storage tank which is precise, creditable and standard, and can be used for measuring at all times.

In order to monitor the movement of the volume of palm oil for prevention of smuggling, including being able to quickly supervise and manage the stock of palm oil throughout the country,

By virtue of Section 9 (2) and Section 25 (3), (4) of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services therefore issues this Notification, as follows.

Article 1. This Notification shall come into force in all areas of the Kingdom for the period of one year as from the day following the date of its publication, except for there being the issuance of a new notification.

Article 2. The person who takes the possession of the storage tank of palm oil, whether or not taking such possession as an owner, and stores the palm oil as usual, is required to proceed or cooperate with the Department of Internal Trade in installing the gauge for measuring the volume of palm oil contained in a storage tank which is precise, creditable and standard, and can be used for measuring at all times. The rules, procedures, duration, methods and conditions for compliance shall be in accordance with the stipulations made by the Secretary-General of the Central Committee on the Price of Goods and Services.
