Notification of the Central Committee on the Price of Goods and Services

No. 1, B.E. 2567 (2024)

Regarding Determination of Additional Goods under Control

Whereas the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, already issued the Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2566 (2023) regarding Determination of Additional Goods under Control dated 19th January B.E. 2566 (2023) to prescribe 5 items of controlled goods, the Notification of the Central Committee on the Price of Goods and Services No. 9, B.E. 2566 (2023) regarding Determination of Goods and Services under Control dated 29th June B.E. 2566 (2023) to prescribe 46 items of controlled goods and 5 items of controlled services, and the Notification of the Central Committee on the Price of Goods and Services No. 67, B.E. 2566 (2023) regarding Determination of Additional Goods under Control dated 31st October B.E. 2566 (2023) to prescribe that granulated sugar was goods under control.

Whereas the Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2566 (2023) regarding Determination of Additional Goods under Control dated 19th January B.E. 2566 (2023) has enforcement only for one year. And the Central Committee on the Price of Goods and Services has already reconsidered the exercise of such power, it is of the view that there should be the maintenance of the five items of controlled goods in order to monitor and prevent the fixing of purchase price, distribution price or the imposition of conditions and trade practices in an unfair manner.

By virtue of Section 9 (1) and Section 24 of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, therefore issues this Notification, as follows.

Article 1. This Notification shall come into force as from the date of its publication in the Government Gazette onwards¹ until the 30th Day of June B.E. 2567 (2024) except for there being the issuance of a new notification.

Article 2. The Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2566 (2023) regarding Determination of Additional Goods under Control dated 19th January B.E. 2566 (2023) shall be repealed.

Article 3. The following goods shall be goods under control:

- (1) hygienic mask,
- (2) polypropylene (spunbond) to be used in the production of hygienic mask,
- (3) product which contains alcohol as a component for hand hygiene,
- (4) waste paper and reused paper,
- (5) chicken, chicken meat.
