Notification of the Central Committee on the Price of Goods and Services

No. 13, B.E. 2565 (2022)

Regarding Determination of Goods and Services under Control

Whereas the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, already issued the Notification of the Central Committee on the Price of Goods and Services No. 8, B.E. 2564 (2021) regarding Determination of Goods and Services under Control dated 28th June B.E. 2564 (2021) to prescribe 46 items of controlled goods and 5 items of controlled services, and the Notification of the Central Committee on the Price of Goods and Services No. 5, B.E. 2565 (2022) regarding Determination of Additional Goods under Control dated 25th January B.E. 2565 (2022) to prescribe 5 items of additional controlled goods.

Whereas the Notification of the Central Committee on the Price of Goods and Services No. 8, B.E. 2564 (2021) regarding Determination of Goods and Services under Control dated 28th June B.E. 2564 (2021) has enforcement only for one year. And the Central Committee on the Price of Goods and Services has already reconsidered the exercise of such a power, it is of the view that there should be the maintenance of 46 items of controlled goods and 5 items of controlled services, in order to monitor and prevent the fixing of purchase price, distribution price or the imposition of conditions and trade practices in an unfair manner.

By virtue of Section 9 (1) and Section 24 of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, there issues this Notification, as follows.

Article 1. This Notification shall come into force for the period of one year from 1^{st} July B.E. 2565 (2022) onwards, except for there being the issuance of a new notification.

Article 2. The following goods and services are goods and services under control.

the category of paper and products

- (1) corrugated cardboard, kraft paper
- (2) printing and writing paper

the category of transportation hardware

- (3) motorcycle tire, automobile tire
- (4) motorcycle, small truck

the category of agriculture materials

- (5) distillers dried grians (DDGs)
- (6) water pump
- (7) fertilizer
- (8) pesticides or fungicides
- (9) rice combine harvester
- (10) tractor
- (11) animal feed and concentrated feed

the category of petroleum products

- (12) liquefied petroleum gas
- (13) fuel oil

the category of medicine and medical supplies

- (14) medicine
- (15) medical supplies for treatment

the category of construction materials

- (16) PVC pipe
- (17) cement
- (18) electrical wire
- (19) structural steel, flat steel, rebar

the category of important agricultural goods

- (20) paddy, rice
- (21) wheat, barley
