### Notification of the Central Committee on the Price of Goods and Services

No. 1, B.E. 2561 (2018)

Regarding Determination of Goods and Services under Control

Whereas the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, already issued the Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2560 (2017) regarding Determination of Goods and Services under Control dated 19 January B.E. 2560 (2017) to prescribe 42 items of controlled goods and 5 items of controlled services.

Whereas the abovementioned notification has come into force only for one year, and when the Central Committee on the Price of Goods and Services has already reconsidered its power regarding an issuance of such notification, it is of the view that the details of item of goods should be added on, and certain items of controlled goods should be added on, in order to monitor and prevent the unfairness of the determination of purchase price, distribution price or the determination of conditions and trade practices.

By virtue of Section 9 (1) and Section 24 of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services, with the approval of the Council of Ministers, has therefore issued this Notification, as follows.

**Article 1.** This Notification shall come into force for the period of one year as from the date of its publication in the Government Gazette.<sup>1</sup>

**Article 2.**The Notification of the Central Committee on the Price of Goods and Services No. 1, B.E. 2560 (2017) regarding the Determination of Goods and Services under Control dated 19 January B.E. 2560 (2017) shall be repealed.

**Article 3.** The following goods and services shall be goods and services under control.

### category of paper and products

- (1) corrugated cardboard, kraft paper
- (2) printing and writing paper
- (3) paper pulp
