## Notification of the Central Bureau of Weights and Measures

Regarding Prescription on Training Agency and Issuance of Certificate in Completion of Measurement Training

Whereas the Ministerial Regulation Laying down Rules Governing Business Operation in respect of Measurement and Registration of Identification Mark, B.E. 2563 (2020) has prescribed that a person with an intention to run the business of the manufacture, import or repair of measuring instruments is required to apply for a certificate of business operation and notify a competent official of the business operation together with information, document or evidence as stipulated, and to comply with rules as imposed. In addition, the personnel of the aforesaid business operator shall have knowledge and capability whereby they are required to receive a certificate in the completion of training issued by the agency that is stipulated by the Central Bureau of Weights and Measures.

In order that the measurement training as to be given to the personnel of the business operator of the manufacture, import or repair of the measuring instruments by the agency as to be stipulated by the Central Bureau of Weights and Measures shall be in good order and the same standards; by virtue of Article 4 (3) of the Ministerial Regulation Laying down Rules Governing Business Operation in respect of Measurement and Registration of Identification Mark, B.E. 2563 (2020), the Director-General of the Department of Internal Trade therefore issues this Notification, as follows.

**Article 1.** This Notification shall come into force as from the day following the date of its publication in the Government Gazette onwards.<sup>1</sup>

**Article 2.** The agency that shall provide the training and issue the certificate in the completion of the measurement training to the personnel of the business operator of the manufacture, import or repair of the measuring instruments is the Central Bureau of Weights and Measures, the Department of Internal Trade, the Ministry of Commerce.
