Notification of the Central Bureau of Weights and Measures

Regarding Prescription on Application Form and Permit to Be Person to Inspect and Verify

Measuring Instruments Manufactured or Repaired by Manufacturer or Repairer¹

Whereas the Ministerial Regulation regarding Permission Granted to Manufacturer or Repairer to Be Person to Inspect and Verify Measuring Instruments Manufactured or Repaired by Such Manufacturer or Repairer, B.E. 2563 (2020) issued under the Measurement Act, B.E. 2542 (1999) and as amended has prescribed that the Central Bureau is empowered to prescribe the forms of an application for the permission, an application for the renewal of the permit, an application for a permit substitution, the permit and the permit substitution to be a person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer.

In order that the application for the permission, the application for the renewal of the permit, the issuance of the permit, the permission for the renewal of the permit and the issuance of the permit substitution to be the person to inspect and verify the measuring instruments of the manufacturer or the repairer shall be in order, by virtue of Article 3, paragraph two of Article 6, paragraph two of Article 7, Article 8, and paragraph one and paragraph three of Article 9 of the Ministerial Regulation regarding Permission Granted to Manufacturer or Repairer to Be Person to Inspect and Verify Measuring Instruments Manufactured or Repaired by Such Manufacturer or Repairer, B.E. 2563 (2020), the Director-General of the Department of Internal Trade therefore issues this Notification, as follows.

Article 1. This Notification shall come into force as from the date of its publication.

Article 2. The application for the permission, the application for the renewal of the permit and the application for the permit substitution to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall take the following forms:

(1) the application for the permission to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall be in accordance with Form ChorVor. 4101 as attached to this Notification,

- (2) the application for the renewal of the permit to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall be in accordance with Form ChorVor. 4102 as attached to this Notification,
- (3) the application for the permit substitution to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall be in accordance with Form ChorVor. 4103 as attached to this Notification.
- **Article 3.** The permit, the permission for the renewal of the permit and the permit substitution to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall take the following forms:
- (1) the permit to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall be in accordance with Form ChorVor. 4101 -1 as attached to this Notification,
- (2) the permission for the renewal of the permit to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall take the form of the permit under (1), and the wording of the renewal and the term of the renewal shall also be specified in the final part of the aforesaid permit,
- (3) the permit substitution to be the person to inspect and verify the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall take the form of the permit under (1), and the wording "a permit substitution" shall be specified in the upper part of the aforesaid permit.
- **Article 4.** An application for changing or adding a measurement standard or a laboratory or a place or personnel for the inspection and verification of the measuring instruments as manufactured or repaired by the manufacturer or the repairer shall be in accordance with Form ChorVor. 4104 as attached to this Notification.
