Notification of the Central Committee on the Price of Goods and Services

No. 51, B.E. 2562 (2019)

Regarding Display of Purchase Price of Agricultural Goods

Whereas the Central Committee on the Price of Goods and Services has issued the Notification of the Central Committee on the Price of Goods and Services No. 51, B.E. 2561 (2018) regarding Display of Purchase Price of Agricultural Goods dated 23 January B.E. 2561 (2018) in order that an agriculturist shall have an opportunity to make a comparison of purchase price before making a decision to sell goods and to avoid being unfairly taken advantage of purchase price.

Whereas the Central Committee on the Price of Goods and Services has already reconsidered the measure on the display of purchase price of agricultural goods, it is of the view that the measure requiring display of purchase price of agricultural goods should be maintained.

By virtue of Section 9 (5) and Section 28 of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services has therefore issued this Notification, as follows.

Article 1. This Notification shall come into force in all areas of the Kingdom as from the day following the date of its publication.

Article 2. The Notification of the Central Committee on the Price of Goods and Services No. 51, B.E. 2561 (2018) regarding the Display of Purchase Price of Agricultural Goods dated 23 January B.E. 2561 (2018) shall be repealed.

Article 3. A business operator who purchases agricultural goods for production or distribution shall have to label the display of name and the purchase price of agricultural goods pursuant to the List as attached to this Notification.

In a case where the purchase price of agricultural goods has relationship with category, type, quality, grade, moisture and impurities, the display of the purchase price shall be made concurrently with the aforesaid contents or items.

Article 4. The display of the purchase price of agricultural goods under Article 3 shall be made by writing, printing or making appearance by other methods on paper, wood,

mirror, wall or any other material. Such display shall be made at the place of purchase or the nearby area of the purchase place.

The display of the purchase price of agricultural goods shall be made in the form of the price per unit, regardless of whether there are figures of any language or not; however, there must be Arabic figure in the display in the high size of not lower than ten centimeters in the manner of being clear and disclosed, in capable of being easily read. The contents or items to be displayed concurrently with the purchase price must be made in Thai language, regardless of whether there are other foreign languages or not.

Article 5. The display of the purchase price of agricultural goods under Article 3 shall be made in line with the price as purchased.

Article 6. In a case of there being the deduction of weight, moisture, impurities or other item out of the purchase price as displayed under Article 3, the business operator shall have to clearly and completely display the detail of such deduction. Such display shall be made concurrently with that of the purchase price of agricultural goods.
