

**Notification of the Department of Internal Trade**

Regarding Rules, Procedures and Conditions in relation to Submission of Application,  
Declaration of Information, and Submission of Annual Report under Law Governing  
Warehouse, Silo and Cold Storage via Electronic Data System (No. 2)<sup>1</sup>

Whereas the Department of Internal Trade already issued the Notification of the Department of Internal Trade regarding Rules, Procedures and Conditions in relation to Submission of Application, Declaration of Information, and Submission of Annual Report under Law Governing Warehouse, Silo and Cold Storage via Electronic Data System, dated 29<sup>th</sup> March B.E. 2565 (2022), prescribing the rules, procedures and conditions in relation to the submission of an application, the declaration of information, and the submission of an annual report via the electronic data system under the law governing warehouse, silo and cold storage in order to facilitate the operator of warehouse business, silo business or cold storage business; subsequently, the Committee for Supervising Warehouse, Silo and Cold Storage already issued the Notification of the Committee for Supervising Warehouse, Silo and Cold Storage regarding Rules, Procedures and Conditions in relation to Application for and Granting Permission for Depositing Money Anywhere other than Bank or Finance Company, dated 20<sup>th</sup> November B.E. 2566 (2023), prescribing the rules, procedures and conditions in relation to applying for and granting permission for depositing money anywhere other than the bank or the finance company.

In order to prescribe the rules, procedures and conditions in relation to the submission of an application for the permission for depositing money anywhere other than the bank or the finance company to be consistent with the promotion of the government policy on the provision of services to people with the electronic system, to reduce the steps and the duration of the submission of the application, and to facilitate the submission of the aforesaid application under the law governing warehouse, silo and cold storage, by virtue of paragraph four of Article 3 of the Notification of the Department of Internal Trade regarding

Rules, Procedures and Conditions in relation to Declaration of Information concerning Warehouse, Silo and Cold Storage Maintaining Goods only for Affiliated Company, dated 4<sup>th</sup> April B.E. 2559 (2016), the Notification of the Department of Internal Trade regarding Rules, Procedures and Conditions in relation to Declaration of Intention not to Carry on Business or to Discontinue Warehouse Business, Silo Business or Cold Storage Business, dated 4<sup>th</sup> April B.E. 2559 (2016), the Notification of the Department of Internal Trade regarding Annual Report Form, Balance sheet and Profit and Loss Account, dated 4<sup>th</sup> April B.E. 2559 (2016), and the Notification of the Department of Internal Trade regarding Form and Procedures for Submission of Form of Annual Report Indicating Information on Goods Maintained only for Affiliated Company, dated 4<sup>th</sup> April B.E. 2559 (2016), Article 4 (4) of the Notification of the Committee for Supervising Warehouse, Silo and Cold Storage regarding Rules, Procedures and Conditions in relation to Application for and Granting Permission for Depositing Money Anywhere other than Bank or Finance Company, dated 20<sup>th</sup> November B.E. 2566 (2023), Article 4 (4), paragraph two of Article 9 and paragraph two of Article 10 of the Notification of the Committee for Supervising Warehouse, Silo and Cold Storage regarding Rules, Procedures and Conditions in relation to Permission for Business Operation, Issuance of License Substitute, Renewal of License and Return of Goods in case of Winding up Business, dated 22<sup>nd</sup> June B.E. 2559 (2016), Article 4 (4) and paragraph two of Article 8 of the Notification of the Committee for Supervising Warehouse, Silo and Cold Storage regarding Rules, Procedures and Conditions in relation to Permission for Having Branch Office and Issuance of License Substitute, dated 22<sup>nd</sup> June B.E. 2559 (2016), Article 5 (4) and paragraph three of Article 6 of the Notification of the Committee for Supervising Warehouse, Silo and Cold Storage regarding Rules, Procedures and Conditions in relation to Declaration on Renting out more than Fifty Percent of Total Area of Warehouse, Silo or Cold Storage, dated 22<sup>nd</sup> June B.E. 2559 (2016), Article 6 (4) of the Notification of the Committee for Supervising Warehouse, Silo and Cold Storage regarding Rules, Procedures and Conditions in relation to Application for Permission and Granting Permission for Reducing Capital, dated 22<sup>nd</sup> June B.E. 2559 (2016), the Director-General of the Department of Internal Trade therefore issues this Notification, as follows.

**Article 1.** This Notification shall come into force as from the day following the date of its publication onwards.

**Article 2.** The provision in (1) of Article 8 of the Notification of the Department of Internal Trade regarding Rules, Procedures and Conditions in relation to Submission of Application, Declaration of Information, and Submission of Annual Report under Law Governing Warehouse,

Silo and Cold Storage via Electronic Data System, dated 29<sup>th</sup> March B.E. 2565 (2022) shall be repealed, and the following provision shall be replaced :

“(1) To access the electronic data system via the website of the Department of Internal Trade ([www.dit.go.th](http://www.dit.go.th)) by selecting “the service menu”, clicking “e-service”, and then choosing “the online service for the operator of warehouse, silo and cold storage” respectively, or to access the system directly at <https://ewsc.dit.go.th>, clicking “to enter the system”, and then choosing “the operator” by using the username and the password which have been provided by the Department of Internal Trade under Article 5.”

**Article 3.** The following provision shall be added to be (j) of (2) of Article 8 of the Notification of the Department of Internal Trade regarding Rules, Procedures and Conditions in relation to Submission of Application, Declaration of Information, and Submission of Annual Report under Law Governing Warehouse, Silo and Cold Storage via Electronic Data System, dated 29<sup>th</sup> March B.E. 2565 (2022) :

“(j) an application form for permission for depositing money anywhere other than the bank or the finance company”

**Article 4.** The provision in (1) of Article 9 of the Notification of the Department of Internal Trade regarding Rules, Procedures and Conditions in relation to Submission of Application, Declaration of Information, and Submission of Annual Report under Law Governing Warehouse, Silo and Cold Storage via Electronic Data System, dated 29<sup>th</sup> March B.E. 2565 (2022) shall be repealed, and the following provision shall be replaced :

**Article 5.** The provision in (1) of Article 10 of the Notification of the Department of Internal Trade regarding Rules, Procedures and Conditions in relation to Submission of Application, Declaration of Information, and Submission of Annual Report under Law Governing Warehouse, Silo and Cold Storage via Electronic Data System, dated 29<sup>th</sup> March B.E. 2565 (2022) shall be repealed, and the following provision shall be replaced :

“(1) To access the electronic data system via the website of the Department of Internal Trade ([www.dit.go.th](http://www.dit.go.th)) by selecting “the service menu”, clicking “e-service”, and then

choosing “the online service for the operator of warehouse, silo and cold storage” respectively, or to access the system directly at <https://ewsc.dit.go.th>, clicking “to enter the system”, and then choosing “the operator” by using the username and the password which have been provided by the Department of Internal Trade under Article 5.”

**Article 6.** All of the application form, the form of the declaration of information, and the form of an annual report which have been submitted prior to the date when this Notification comes into force and still under the consideration of a competent official shall be deemed to be the submission of the application, the declaration of information, and the submission of an annual report under this Notification, *mutatis mutandis*.
