

**Notification of the Operating Committee under the Rice Trading Act
Buddhist Era 2489 (1946)**

No. 154, B.E. 2568 (2025)

Regarding Making Improvement on Requirement for Business Operator of Rice Trading to Apply for Permission for Operating Rice Trading, Stipulation as to Conditions in Letter of Permission for Operating Rice Trading and Withdrawal of Letter of Permission for Operating Rice Trading

Whereas the Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946) already issued the Notification of the Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946), No. 150, B.E. 2560 (2017) regarding Requirement for Business Operator of Rice Trading to Apply for Permission for Operating Rice Trading, Stipulation as to Conditions in Letter of Permission for Operating Rice Trading and Withdrawal of Letter of Permission for Operating Rice Trading dated 9th February B.E. 2560 (2017) as amended by the Notification of the Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946), No. 153, B.E. 2567 (2024) regarding Making Improvement on Requirement for Business Operator of Rice Trading to Apply for Permission for Operating Rice Trading, Stipulation as to Conditions in Letter of Permission for Operating Rice Trading and Withdrawal of Letter of Permission for Operating Rice Trading dated 26th January B.E. 2567 (2024), for requiring the business operator of rice trading to apply for the permission for operating the rice trading, stipulating the conditions in a letter of permission for operating the rice trading and the withdrawal of a letter of permission for operating the rice trading.

The Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946) passed a resolution on 17th January B.E. 2568 (2025) approving making the improvement on condition that it is required to comply with a letter of permission for the business operator of rice trading in the type of trading by exporting rice to a foreign country as a general exporter in order to reduce an obstruction and to encourage the business operator to be able to export more rice.

By virtue of Section 9 of the Rice Trading Act Buddhist Era 2489 (1946) as amended by the Rice Trading Act (No. 2) Buddhist Era 2489 (1946), the Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946) therefore issues this Notification as follows.

Article 1 This Notification shall come into force as from the day following the date of its publication in the Government Gazette¹ onwards.

Article 2 The provision in (1) of Article 18 of the Notification of the Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946), No. 150, B.E. 2560 (2017) regarding Requirement for Business Operator of Rice Trading to Apply for Permission for Operating Rice Trading, Stipulation as to Conditions in Letter of Permission for Operating Rice Trading and Withdrawal of Letter of Permission for Operating Rice Trading dated 9th February B.E. 2560 (2017) shall be repealed, and the following provision shall be replaced :

“(1) shall own milled rice not less than the following specified quantities within fifteen days as from the date of the issuance of the Letter of Permission for Operating Rice Trading and throughout a period of holding the Letter of Permission for Operating Rice Trading

(a) not less than one hundred metric tons as for the company having a registered capital not exceeding ten million baht,

(b) not less than five hundred metric tons as for the company having a registered capital exceeding ten million baht but not exceeding twenty million baht,

(c) not less than one thousand metric tons as for the company having a registered capital exceeding twenty million baht.”

Article 3 The form of a letter of permission for operating rice trading in the type of trading by exporting rice to a foreign country (a general exporter) (Form Cor.Khor. 6) as attached to the Notification of the Operating Committee under the Rice Trading Act Buddhist Era 2489 (1946), No. 153, B.E. 2567 (2024) regarding Making Improvement on Requirement for Business Operator of Rice Trading to Apply for Permission for Operating Rice Trading, Stipulation as to Conditions in Letter of Permission for Operating Rice Trading and Withdrawal of Letter of Permission for Operating Rice Trading dated 26th January B.E. 2567 (2024), shall be repealed, and the form of a letter of permission for operating rice trading in the type of trading by exporting rice to a foreign country (a general exporter) (Form Cor.Khor. 6) as attached to this Notification shall be used stead.

Article 4 All of the letters of permission for operating the rice trading in the type of trading by exporting rice to a foreign country as a general exporter which have been granted on the days prior to the date when this Notification comes into force shall still be valid until such letters of permission for operating the rice trading shall expire whereby it is required to comply with the conditions as specified in this Notification as well.
