Regarding Forms for Declaration Pursuant to Notification of
the Central Committee on the Price of Goods and Services (No.2)¹

Whereas the Central Committee on the Price of Goods and Services issued the Notification of the Central Committee on the Price of Goods and Services No. 4, B.E. 2568 (2025) regarding Determination of Goods and Services under Control dated 26th June B.E. 2568 (2025) and the Notification of the Central Committee on the Price of Goods and Services regarding the stipulation of measure to declare the information relating the price, the payment, the capital cost, the expense, the importation plan, the details of goods, the quantity and the storage place of toilet paper, tissue paper, corrugated cardboard, Kraft paper, printing and writing paper, garlic imported from foreign countries, DDGS: distillers dried grains with solubles to be used as animal-feed raw material imported from foreign countries, liquefied petroleum gas filled in a container (LPG), license to publicize copyright work relative to song for commercial purpose, chicken, chicken meat, animal feed corn, wheat and barley to be used as animal-feed raw material imported from foreign countries, air purifier, water pump, test kit products and reagents relating to the diagnosis of SARS-Cov-2 infection (a COVID-19 pathogen), COVID-19 antigen test self-test kits, shampoo, electric vacuum cleaner (vacuum cleaner), powder milk, pam oil, medical treatment, medical service, and other service of clinics, chemical fertilizer, cement, wheat flour, detergent, liquid detergent, oil palm seed, products which contain alcohol as a component for hand hygiene, ready-to-consume milk products in liquid, dishwashing product, sanitary napkin, tapioca chip, pesticides or fungicides, medicines, para rubber, motorcycle tire, automobile tire, rice combine harvester, tractor, motorcycle, truck, medical supplies, waste paper and reused paper, electrical wire, soap, liquid soap, pig, pork, hygienic mark, concentrated feed, animal feed, structural steel, steel plate, rebar, pre-cooked food packaged in
