

Regulation of the Office of the Central Committee on the Price of Goods and Services

Governing Certification of Transport of Paddy, Rice Leaving Other District Area in the Kingdom,
whereby Area of Controlled District shall be Gateway of Transport to Destination Place,

B.E. 2562 (2019)

Whereas the Central Committee on the Price of Goods and Services has issued the Notification of the Central Committee on the Price of Goods and Services No. 4, B.E. 2562 (2019) regarding Control of Transport of Paddy, Rice dated 22 January B.E. 2562 (2019) to prohibit any person to transport paddy, rice whereby the quantity of which per each time of transport starts from ten metric tons upward leaving the specified district areas except for receiving a letter of permission. The aforesaid prohibition shall not be applicable to the transport of paddy, rice leaving other district area in the Kingdom, whereby the area of the controlled district shall be the gateway of transport to the destination place, and the application for permission for the transport is not required.

In order to be advantageous to a competent officer in investigating and monitoring during the time of the transport of paddy, rice leaving other district area, whereby the area of the controlled district shall be the gateway of transport to the destination place, and in order to facilitate to all parties involved, by virtue of Section 16 (5) of the Price of Goods and Services Act, B.E. 2542 (1999), the Secretary-General of the Central Committee on the Price of Goods and Services has therefore issued this Regulation, as follows.

Article 1. This Regulation is called the “Regulation of the Office of the Central Committee on the Price of Goods and Services Governing Certification of Transport of Paddy, Rice Leaving Other District Area in the Kingdom, whereby Area of Controlled District shall be Gateway of Transport to Destination Place, B.E. 2562 (2019)”

Article 2. This Regulation shall come into force as from the date of its publication onwards.¹

Article 3. The person who wishes to transport paddy or rice whereby the district area, under the Notification of the Central Committee on the Price of Goods and Services No. 4, B.E. 2562 (2019) regarding Control of Transport of Paddy, Rice dated 22 January B.E. 2562 (2019), shall be the gateway of transport to the destination place, and has an intention to receive the certification of transport of paddy, rice in the aforesaid case, he/she is required to file an application for certification in accordance with a form as attached to this Regulation.

The application for the certification of transport of paddy or rice as specified in paragraph one shall be filled with information by writing or typing in a manner of completeness, clearness and being readable.

Article 4. In applying for the certification of transport of paddy or rice as specified in Article 3, the applicant for certification shall have to file the application together with a copy of identity card to a competent officer at the governmental offices, as follows:

- (1) the Office of the Central Committee on the Price of Goods and Services, the Department of Internal Trade, the Ministry of Commerce, in a case where Bangkok Metropolis is the area in which the transport originally takes place;
- (2) the Provincial Commercial Office in the area in which the transport originally takes place.

Article 5. When the competent officer has received the application for certification together with the supporting documents as specified in Article 4, and is of opinion that all the documents are correct and complete, the competent officer who is the public servant in the rank of operational level or practitioner level upward shall consider certifying the transport of paddy or rice.

Article 6. When the competent officer has certified the transport of paddy or rice under Article 5, the following actions shall be taken.

- (1) The original application for the certification of transport of paddy or rice shall be given to the applicant for certification in order to be brought with a vehicle to be used for the transport.
- (2) The duplicate application for the certification of transport of paddy or rice shall be kept at the office of the government agency who is in charge of certifying the transport of paddy or rice.

Article 7. The Secretary-General of the Central Committee on the Price of Goods and Services shall have charge and control of the execution of this Regulation.

- In applying for the certification in a case where Bangkok is the starting place of transport, the application shall be filed to the Office of the Central Committee on the Price of Goods and Services, the Department of Internal Trade, the Ministry of Commerce; or in a case where other province is the starting place of transport, the application shall be filed to the Provincial Commercial Office of the area.

- The supporting document of the application is a copy of identity card of the applicant for certification.
