

Notification of the Central Committee on the Price of Goods and Services

No. 71, B.E. 2566 (2023)

Regarding Setting of Distribution Price on Granulated Sugar¹

Whereas the Central Committee on the Price of Goods and Services already issued the Notification of the Central Committee on the Price of Goods and Services No. 68, B.E. 2566 (2023) regarding Setting of Distribution Price on Granulated Sugar dated 1st November B.E. 2566 (2023) prescribing that a producer, a distributor of white sugar, pure white sugar in specified areas shall distribute the white sugar, the pure white sugar at a price not higher than the price as set.

Whereas the Central Committee on the Price of Goods and Services passed a resolution on 14th November B.E. 2566 (2023) reconsidering the setting of distribution price on the granulated sugar by adjusting the distribution price at a factory in order that the distribution price of the granulated sugar shall be suitable and consistent with the structure of capital costs imposed by the Office of the Cane and Sugar Board, and fair to all parties involved.

By virtue of Section 9 (2), Section 25 (1), (4) of the Price of Goods and Services Act, B.E. 2542 (1999), the Central Committee on the Price of Goods and Services therefore issues this Notification, as follows.

Article 1. This Notification shall come into force in all areas of the Kingdom for the period of one year as from the day following the date of its publication, except for there being the issuance of a new notification.

Article 2. The Notification of the Central Committee on the Price of Goods and Services No. 68, B.E. 2566 (2023) regarding Setting of Distribution Price on Granulated Sugar dated 1st November B.E. 2566 (2023) shall be repealed.

Article 3. The distribution of the white sugar, the pure white sugar at the front of the factory shall be made at a price not higher than the price as set as follows:

- (1) the price of the white sugar being 21.00 baht per kilogram,
- (2) the price of the pure white sugar being 22.00 baht per kilogram,

Article 4. This Notification shall not apply to the white sugar, the pure white sugar in the type of chunk, in the type which is contained in a pack, having a net quantity not exceeding ten grams per pack, and contained in a box or other containers, and in the type which is contained in a bottle, a box or a container with a special feature.

Article 5. The distribution of the white sugar, the pure white sugar, the quantity of which is lower or higher than a unit which is specified in Article 3, shall be calculated for the price according to the ratio.
